The assessment is also carried out remotely, while connected to the online video meeting/conferencing platform but you must also be able to undertake the multiple-choice assessment electronically through a web browser (Edge, Chrome etc). Full instructions will be provided.

## **Course IT Requirements**

Each delegate will need a Windows or Mac PC, with built in or external camera. The course can also be delivered on a tablet, but we recommend at least a 10.5-inch screen. The assessment will use a web application, running on a standard web browser.

The delegate will need to switch on the camera and be able to use the microphone during the training sessions and the assessment.
